While all applicants will be accepted, there is a limit on the number of CITs we can accept each week, therefore, completed applications will be processed on a first-come, first-served basis. The earlier you get your application, the better.

CHOOSE YOUR CAMP

CITs can request to participate in any two weeks of the following camp programs (if space is available):

- Harry Potter Camp
 - June 25 – 29
 - July 2 – 6 (No Camp on July 4)
 - July 9 – 13
- Harry Potter Family Camp*
 - July 16 – 17
- Camp Half-Blood
 - July 23 – 27
- Camp Jupiter
 - July 20 – August 3
- Star Wars: Padawan Camp
 - August 6 – 10
- Avengers Training Academy
 - August 13 – 17

*NOTE: Because the Harry Potter Family Camp is only two days long, it does not count for your two weeks. Any approved CIT is welcome to help, free of charge, during those two days.

PROGRAM FEE

The fee for returning FA CITs is \$280 for 2 weeks.

The fee for first year FA CITs is \$380 for 2 weeks and includes:

- Training
- Supervision/Mentoring
- 1-on-1 Evaluations
- T-shirts
- Lunch on Fridays
- Ferry Tickets and/or Specific Camp Items (i.e. wand, owl, etc. for Harry Potter Camp)

ASSIGNMENTS

New or Returning FA CITs must commit to **a minimum of two weeks**. CITs must request specific dates and camp(s).

INTERESTED IN RETURNING FOR EXTRA WEEKS?

If, after you have completed the 2 weeks of the CIT program, and you would like to return to camp for additional weeks, you may attend camp with approval from the CIT Director and AI Camp Director (you will be charged an additional \$50 per week).

*NOTE: The \$50 per additional week charge does not apply to the Harry Potter Family Camp.

Review the following before applying to be a Counselor-In-Training:

- Only new Fantastical Adventures CIT applicants are required to attend our FA CIT Orientation on Wednesday, May 23rd from 5pm – 8pm. If you are a returning FA CIT, you are welcome to attend and help share your experiences as a veteran CIT. This is mandatory for all new FA CITs. *No exceptions.*
- Camps are structured with the campers' happiness and, most importantly, their safety in mind. To ensure the camp's quality, we ask that only those who are genuinely interested in working with children, and are able to fulfill the commitment as outlined, apply to be a CIT. ***The CIT assignment can be discontinued at any time if it is in the best interest of the program/campers to do so.***
- CITs are expected to arrive and depart according to their assigned schedule and complete assignments.

Qualifying applicants will have....

- Completed at least the 7th grade or higher by the start of 2018 camp season.
- Be able to attend camp each day of the assigned weeks Mon-Fri from 8:30am-4:30pm.
