IV. Discussion Items

A. Pickleball at Lagoon Road Courts update

STAFF REPORT The City of Belvedere (COB) has decided to allow regular play of pickleball at the Lagoon Road Court with play between of 9am-6pm only and limited to one net and a max of 4 people. The COB is researching options on how to limit hours of play.

The Town of Tiburon POST Commission will hold a final vote to approve or not approve the addition of pickleball courts, on a trial basis, to the Point Tiburon Courts on Tuesday, Sept 16, 2021. Recreation Director Jessica Hotchkiss will be attending that meeting.

B. Tennis Court Key Options

STAFF REPORT The Ranch rekeys their courts each April 1st. We have been researching alternative entrance options for our tennis court location in order to have better control of who is accessing the courts as well as the opportunity to suspend court access mid-year to those that are not following the tennis court rules. At this time we have not found a better alternative than the key system we currently have in place for several reasons. There are card and fob systems, but they all require full overhauls of the current 4 court access gates and access to wifi for the gate scanners to work. It is also difficult to find a system that could create unique user codes that can be changed annually. The Ranch reached out to all other Park and Rec Departments in Marin to see if others have researched card or fob systems and the few that did had chosen against a card or fob options due to maintenance issues associated with these types of systems and lack of local repair crew when the systems do break. The Ranch currently works with a local key company that has always been able to come out to our courts and fix any lock issues we have ever had within the day. There is still time to continue to research this project and the Recreation Director will provide options to the board and related court City and Town if a good system is found.

C. Adult Sport use at McKegney Green

STAFF REPORT The Town of Tiburon POST Commission and Tiburon Town Council recently update the usage policies for McKegney Green. The usage of the field space is now open to adults, with restrictions, and with priority use still going to youth related programs.

The current restrictions for adult use, which has the lowest level of priority use, are:

- Adults use limited to soccer only
- Majority of the adult teams must be from the 94920 area code

Now that The Ranch has knowledge of the newly approved parameters, we will apply for use to create an adult soccer program. It will be a challenge to find daylight time in between the children's lacrosse and soccer schedules that have priority, but as a recreation organization, we would be doing ourselves and our local adult athletes a disservice if we didn't try to secure some time.

V. Finance Reports

A. Review of financials of 2020-21 Fiscal Year through Sept. 2021

STAFF REPORT When creating the budget for the 2021-22 fiscal year we made projections based upon Adult and Senior programs bouncing back quickly as they were the first population to be vaccinated and youth programs not being as well attended as they were the unvaccinated population and we thought parents may be hesitant to enroll. We see now that the Adult and Senior programs are still struggling due to pandemic rules and policies and youth programming is in high demand. Many of our youth programs are sold out due to popular classes and new contract programs. To date our youth related Fall revenue has brought in gross revenue figures similar to our 2019-2020 Fiscal Year.

This Fall we have served had over 900 children in youth programs, 200 enrolled in our sold out tennis classes. With the rollout of boosters for seniors and the recent lifting of the mask mandate we hope to see attendance improve in our adult programs.

Since The Ranch has been doing financially better than expected, we have been able to complete some maintenance projects that have been deferred over the past two years and purchase some much needed new office equipment.

The Ranch is already working on the 2022-2023 fiscal year budget keeping in mind the following:

- changing town demographics
- $\hbox{-} \ decline in \ the \ public \ school \ population$
- mindfully pricing our programs to remain competitive with similar recreation programming and increases to department expenses

The current average cost per hour of a children's afterschool program is \$24 an hour and the average cost of an adult program is \$32 an hour. The current average cost of our day camps per hour are \$13 an hour.

The Ranch is currently seeking a part time individual to help with youth programs and has struggled to find a part time candidate that can work the hours we need. The addition of another youth employee would allow us to take more participants in some programs that are currently sold out or capped due to staff to child ratios.
